

# Privacy Policy for Northamptonshire Safeguarding Children Partnership

#### Who we are

This privacy statement provides details about the collection, usage, retention and protection of data which is held by the Northamptonshire Safeguarding Children Partnership (NSCP). The NSCP is committed to ensuring that your privacy is protected, in accordance with the Data Protection Act 2018 and the European General Data Protection Regulation.

The NSCP may change this policy occasionally by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from 1<sup>st</sup> July 2019.

The Children Act 2004 requires each Local Authority to establish a Safeguarding Children Partnership (SCP) for their area and specifies the organisations and individuals that should be represented within the Partnership. The key function of a SCP is to coordinate local work to safeguard and promote the welfare of children and to ensure the effectiveness of what the member organisations do individually and together.

## **Usage of Information**

The NSCPs lawful basis for processing your personal information is based on our legal obligation under the aforementioned legislation and in pursuant to Article 6 (1) (c) of the GDPR.

In relation to the functions and activities of the Safeguarding Partnerships, the Partnership processes personal data, including special categories of personal data. We consider the processing of special category data to be lawful in accordance with Article 9(2) (g) of GDPR as we are acting in the substantial public interest, under our obligations in the aforementioned sets of legislation.

Child Safeguarding Practice Reviews may include data related to criminal convictions. We have official authority, provided by these Acts, to process data relating to criminal record history, in accordance with the requirements of Article 10 of GDPR.

#### How we collect and share your data

The NSCP is made up of statutory members and the strategic partners are:

- West Northamptonshire Council
- North Northamptonshire Council
- Northamptonshire Police
- Northamptonshire Clinical Commissioning Groups (NCCGs)

Information may also be sourced from other organisations that are part of the NSCP.

All Partners act as joint data controllers for the data processed and may be shared between agencies as defined in our information sharing protocol:

#### Retention

All information is stored securely and held as follows:

- Information for the management of the Partnership: six years
- Minutes from the Boards: six years.
- Policies and procedures: six years.
- Audits: six years.
- Learning Reviews: 15 years.



- Information collated for the production of a Child Safeguarding Practice Review (or other type of review), including partner agency information: **15 years** Action plans resulting from a Child Safeguarding Practice Review: **15 years**.
- Child Safeguarding practice Reviews (or other type of review) final reports: 15 years.

## **Your rights**

You have the right to request a copy of information we hold about you and as well as the right to rectification and restriction (to destruction of records only).

## **Cookies**

A cookie is a small file which asks permission to be placed on your computer's hard drive. We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. Declining cookies may limit the way that you are able to interact with our website.

# **Google Analytics**
